

TERMS & CONDITIONS – Healthy Harold Hero Hundred

1. Promoter

1.1 The promoter is **Life Education Centre Foundation Qld Inc. (Life Ed Qld)** (ABN 17 760 280 660) of 61/89 Sunshine Blvd, Mermaid Waters, QLD 4218 ("Promoter").

1.2 All correspondence should be directed to **supporters@lifeedqld.org.au** or 13 QGOV (13 74 68) for regulatory enquiries.

2. Authorising Legislation

2.1 This incentive draw is conducted as a **"Category 4 promotional game"** under *Charitable and Non-Profit Gaming Act 1999 (Qld)* s 17 and s 21. No gaming licence or permit is required because entry is free and prizes are awarded by chance.

2.2 These Terms incorporate the **OLGR "Guide to Category 4 Promotional Games"** conditions, which require (among other things) written terms, a fair draw, record-keeping and delivery of prizes within one month of the draw.

2.3 The Promoter is authorised to fundraise in Queensland under the *Collections Act* 1966 (*Qld*) and has notified the Office of Fair Trading as required.

3. Eligibility

3.1 Entry is automatic and free for individuals who:

a) hold an active fundraising page for **Healthy Harold's Hero Hundred** and

b) have raised the minimum amounts in clause 4 by 31/10/2025 11 :59 pm AEST.

3.2 Entrants under 18 years declare that a parent or legal guardian has consented to their participation. (No alcohol, weapon or gaming-related prizes are offered.)

3.3 An entrant may appear **in only one prize pool** according to their final fundraising total (clause 4.3).

4. Prizes & Entry Pools

4.1 Gift vouchers will be valid for **at least three years** from the date of issue in accordance with Australian Consumer Law.

4.2 The Promoter may substitute a prize with one of equal or higher value if a prize becomes unavailable.

4.3 Example: raise $750 \Rightarrow$ entry only in Draw B; raise $1,200 \Rightarrow$ entry only in Draw C.



5. Promotion Period

- 5.1 Opens 01/10/2025 12:00am and closes 31/10/2025 11:59pm
- 5.2 The draw will be held at Life Ed Qld on 1/11/2025 at 9:00am AEST.

6. Draw Procedure

6.1 Each eligible entry is assigned a unique, sequential number.

6.2 A computer-based random-number generator that meets OLGR technical requirements will be used;

6.3 The **major prize (Draw C) is drawn first**, followed by Draw B then Draw A, satisfying rule that prizes are drawn in descending order of value.

6.4 All decisions are final; no correspondence will be entered into.

7. Winner Notification & Publication

7.1 Winners will be notified by email within two business days of the draw using the address registered on their fundraising page.

7.2 The winners' first name and last initial will be posted:

a) on the closed Facebook group for event fundraisers and

b) on the Promoter's website <u>https://fundraise.lifeedqld.org.au</u>, within five business days.

7.3 By participating, entrants consent to this limited disclosure of personal information.

8. Prize Claim, Delivery & Unclaimed Prizes

8.1 Prizes will be delivered (electronically or by post) **within one month** of the draw, unless a later delivery date is agreed in writing.

8.2 If a prize is not claimed within three months, the Promoter will conduct a redraw using the original method on **1/02/2026**.

9. Verification & Disqualification

9.1 The Promoter may require proof of identity, age, fundraising total and/or compliance with these Terms before awarding a prize.

9.2 Entries generated by scripts, bots or external fundraising pages are invalid.

9.3 The Promoter may disqualify any entrant who tampers with the entry process or whose conduct may jeopardise the fair running of the promotion.

10. Records & Audit

10.1 General gaming records (entry lists, draw logs, winner acknowledgements) will be **retained for at least five years**.

10.2 Records may be provided to the Office of Liquor & Gaming Regulation on request.

11. Liability

11.1 Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) is not responsible for any loss or damage suffered as a result of



accepting a prize.

11.2 Nothing in these Terms limits, excludes or modifies guarantees, warranties or other provisions under the *Competition and Consumer Act 2010 (Cth)* or other law.

12. Privacy

12.1 Personal information is collected to administer this promotion and will be handled in accordance with the Promoter's privacy policy and the Australian Privacy Principles.12.2 Entrants may access or update their information by contacting the Promoter.

13. General

13.1 If the promotion is interfered with or cannot be conducted as planned (including due to pandemic, technical failure or fraud), the Promoter reserves the right to modify, suspend or cancel the promotion subject to written approval of OLGR if required.

13.2 These Terms are governed by the laws of Queensland. Entrants submit to the non-exclusive jurisdiction of Queensland courts.
